- 2. It is understood that Church events and/or ministries will always take precedence for use of the HCPC facilities. Groups will be notified via e-mail of the need to cancel or reschedule a given time/date.
- 3. HCPC is to be notified of any cancellation(s) of scheduled date(s). Groups may use only those room(s) scheduled at the time(s) scheduled. If the need arises for different or an additional room(s), contact the HCPC Facility Coordinator for availability. Groups are expected to leave room(s) in the same condition as found, including table arrangement. Tables/ chairs are not to be taken from other rooms or areas of the church
- 4. HCPC's facility is not available for the purpose of fundraising or "break-even" purposes. Groups/individuals may not charge attendees or request suggested donations to attend an event. Groups will be expected to cover the dollar amount of repairs, cleaning, and/or replacement costs pertaining to any damages that occur as a result of the negligence of the group/individuals.
- HCPC does not assume responsibility for any personal injury, or loss/damage of property associated with the use of HCPC facility, including the use of parking lots. Groups and individuals associated with groups agree to hold harmless HCPC (including HCPC's agents, employees, and representatives) for any and all liability associated with use of HCPC facility.
