Secretary's Report- Jeanne Meier: The secretary was absent entertaining family from out of town. She appointed her husband as her replacement for the night. The December meeting minutes were approved as published in the January newsletter.

Treasurer's Report – Mike Coe: Mike reported a balance of \$3,762.98. The first Summer Quarterly registration has been received. The club received a Thank You letter from the Road Runner Food Bank for our donation last month.

VP Report – Cliff Meier: With the help of two unnamed deputies (unnamed for their own protection) the following fines were levied.

- Mike Coe was fined \$1.00 for getting his motor home stuck (TWICE) while trying to make like a 4X4 climbing ledges at the Rockin' New Years event. It was reported the ledges were about 6 inches high!
- Jeff Rector was fined a quarter for wandering around while trying to find the trail he was leading, also at the Rockin' New Years run. Jeff strongly denied he was wandering, which almost resulted in another fine for not accepting his fine gracefully. This would have been a "whine" fine. Lauri had to pay Jeff's fine for him!

Director Environmental Affairs Report – Mark Werkmeister: The BLM has launched its effort to develop a comprehensive management plan for the Prehistoric Trackways National Monument in the Robledo Mountains northwest of Las Cruces. The trackways sit on top of the Chile Canyons, which are a major portion of the Chile Challenge trails. The scoping period has started, and ends after the public meeting which has yet to be scheduled, but is expected the end of February or sometime in March. We all need to become involved through the comment process because of the expected lack of off road vehicle trails. For more information on how you can help, contact Mark.

Pre-NEPA process comments are needed for the Magdalena District of the Cibola National Forest. We don't run many of the trails in this and therefore we are not familiar with them. Mark is looking to set up a run in that area.

NMOHVA is preparing for the NM 2010 Legislative Session. NMOHVA is trying to have two pieces of legislation introduced, the first is to have additional safety requirements added to a previously-passed OHV bill. The second is to have an economic impact study be conducted of OHV tourism.

The BLM is going to revise the Glade Area/Choke Cherry Canyon Recreation Management Plan. This has not been officially announced yet, but when it is, we need to get involved. This area is at Farmington, NM and is a nationally-known off road area.

The NEPA training is scheduled for January 30.

From the Office of the Director of Environmental Affairs

Hello all,

There is lots of information to pass on this month. Things are really getting busy! It seems like agency deadlines come in bunches. Accidental? Maybe, but please don't let the flurry of activity cause you to miss these important deadlines. Please help by doing your part to attend meetings, send comments, and help keep our roads and trails open.

Prehistoric Trackways National Monument - <u>Scoping Comments are due Feb 10th!</u> Remember that Scoping comments start the official NEPA process, so the comments you submit become a permanent part of the planning project record. Please let the Las Cruces BLM know that you want the Chile Challenge and casual recreational 4WD to be able to continue to use the Chile Canyon trail systems that

are contained within the monument. The existing trails will not damage the fossilized tracks as they are buried under LOTS of dirt and rock.

Cibola National Forest – Mountainair District – We expect the draft Environmental Assessment (EA) to be issued on or about Feb 5th. Once it is issued, we will have 30 days to provide substantive comments on the EA. If you want the Forest Service to send you a CD or hard copy of the draft EA when it comes out, you can contact the District at <u>cibolatravel@fs.fed.us</u> and ask for one. The draft EA and the maps will also be available on the website when they are issued.

Cibola National Forest — Magdalena District — The District has kicked off their preparation for their Proposed Action by holding a series of public meetings this next week. The closest meeting to us is in Socorro on Saturday (info at http://www.fs.fed.us/r3/cibola/travel-management/tm_magdalena/index.shtml). Remember, this is Pre-NEPA as they haven't released the Proposed Action or asked for Scoping comments yet, but this is a good opportunity to have some early influence as to what they include in their Proposed Action.

Santa Fe National Forest – We still expect the Santa Fe National Forest to release their draft EIS in the near future. There will be at least a 45 day period for the public to make substantive comments on the draft EIS.

Farmington BLM - The Glade (aka Chokecherry Canyon) – The 'unofficial' comment period has ended and the BLM is getting ready to host a meeting(s) to present what they heard from the public. It would seem that they are still determined to re-do the management plan for the area regardless of the feedback. I was scheduled to meet with the Cliffhangers up in Farmington Jan 23rd for a strategy meeting, but weather forced a postponement. The trip will probably be rescheduled for early February. <u>It is NOT TOO LATE to send comments</u> to the BLM telling them that they should implement the current management plan and monitor for results before they consider revising the plan again.

The NM Legislative session for 2010 is in full swing up in Santa Fe. This 30-day session is focused on financial and budget matters, but NMOHVA is closely monitoring it for anything that affects motorized recreation. So far, there has been one Memorial introduced (SJM 31) that affects ATV and motorcycle safety training. NMOHVA will send out its Legislative Updates any time anything of interest happens. You can sign up for the free updates (if don't already receive them) by signing up for them at www.nmohva.org. Just hit the big red button!

That is all, but plenty to keep everyone busy. I know you would all rather just go drive your 4WD, but it takes more than vehicle maintenance to keep us out on the roads and trails of New Mexico.

Rockin' New Years at Gordy's Hill

We had a great potluck that evening with lots of hot dishes, including Green Chile Stew, Lasagne, and some Chipotle Potato soup, to name a few. Thanks to everyone who brought wood,

we had a nice fire to keep us warm. Temp overnight dipped into the mid 20s, which wasn't too bad, considering the lows during the few weeks prior had been in the mid to upper teens.



Saturday morning, Leon headed back home (said he had to vacuum his house). We were joined by Dan Pritchard, and guest Greg ("Not-A-Yota") from Alamogordo. Jeff led the group to the Coyote Hills trail. Despite being rated as "extreme", we all gave it our best. I even got to use my new synthetic winch rope for the first time . . . twice! In fact, there was quite a bit of winching on this trail. Next, we headed over to Edge Canyon. Jeff and Greg were the only two brave enough to attempt this trail. The rest of us cheered them on. Most of us had lunch while we watched their slow accent up the very treacherous terrain.

Next we started to head for slightly easier stuff, so the rest of us could participate. Unfortunately, Jan & I ended up heading back to camp to do some minor repairs, so I don't know which trails were done that afternoon. The repairs were not a result of breakage on the trail, rather incorrect installation of a component at a "local shop" a few weeks prior. How To Be A Good Trip Leader

We are always in the need for Trip Leaders. One of the best ways to become a good Trip Leader is get out there and get involved! The more you practice this aspect of camaraderie, the more seasoned and comfortable you will become. While there are born "Leaders", I can't think of anyone who was born to lead trails. I love doing it due to the advantages you are able to take, one of which I will tell you towards the end!

One of the best things you can do is get yourself familiar with the trail. There are databases available that can give you GPS coordinates of every trail the Club has run over the past several years. If you are not good at GPS coordinate use like I am NOT, then get the starting point from someone and you can figure out the rest. Someone in the Club will always be willing to tell you where these trails start. Going there after a snow storm is probably not the time to visit a new trail! Traveling these in dry weather (which New Mexico is famous for) is the best way for you to get to know the trail. Knowing its hard places, fun places, "leany" places, and "most likely a wrong turn place" is something you need to know for every trail you intend to lead. However, there are exceptions.

There is nothing wrong with leading an "exploratory" trial. This is a trail you have never been on. Just remember to have the courtesy to tell your participants that you have never been on this trail before and this run will be considered an "exploratory" trail run. I have run these several times and it is always fun. Usually people have the patience to participate, because it is always better to go 4 wheeling and get lost than, as one Club Member always says "I could have been home mowing the yard"! Yuck!

There are all types of trail runs and there are ALWAYS all types of trail "Runners". Not everyone enjoys a really hard trail. In fact, my experience tells me there are more participants on easy to moderate runs than on hard to extreme runs. People are more comfortable with the easier to moderate runs as they have a lot of money invested and are not willing to risk damaging their "daily driver". I'm sure you can appreciate that. I have been on all types of trails and prefer to drive the moderate ones with the "daily driver" because of the amenities it provides.

Don't forget that you owe it to yourself and the other participants on the trail to have your vehicle in top maintenance condition. Breaking down is never fun for anyone at any time. Major breakage is something else. Always be prepared to make necessary repairs to get you and the others off the trail and back to civilization. This goes for someone else breaking down on your trail. You are responsible for them as well as yourself, and it is your duty to get them off the trail.

As a participant, you have some responsibility also. Always pay attention to the Trip Leader's directions. Nothing is worse than a "renegade" thinking they can do what they want regardless of whether the Trip Leader agrees or not. It is simple, common courtesy to follow the Trip Leader's direction. Keeping up with the Leader is also important. The Trip leader is aware of the time frame to get through the trail and knows about when he/she would like to be off the trail. Stragglers cause concern for the Leader, and if they are near the front of the line, it causes everyone else stress as they feel like you are holding them up. No one will get lost on a trail if everyone follows some simple

rules . . . keep the person behind you in sight ALL the time! This is how NO ONE misses a turn! If the person in front of you is doing their part, you won't miss a turn either.

Stay on the trail! Do not use a "go around" just because it looks easier than the other route EVERYONE else has used! This is why we 4 Wheelers get into trouble in the eyes of the "GAGs" (Green Advocacy Groups—THE ENEMY!). They call these "secondary" routes and they are only a proliferation of a trail or road. If there is mud in the path and everyone else has used that path, then you are obligated to go through the mud. Getting your vehicle muddy is part of the fun! I take it all in stride. (Remember! You could have stayed home and mowed the lawn!)

Pre-running a trail will tell you how to judge the trail for a level of driver. You can tell what is "easy" vs. "moderate" vs. "hard". Letting everyone know of obstacles or "watch its" are a good way to let people know a particular spot may be hard for them. NO ONE wants to roll or tip their vehicle! This is a dangerous sport and anything can happen. Remember too that not everyone has a lot of experience. Make sure you are fully capable of vehicle extraction and get information from other participants that may be more experienced if need be. Assume nothing and expect the unexpected!

My story is a lot longer than I thought, but I have only touched on a few things to make a good Trip Leader. Experience is the best teacher! The thing I like best about being a Trip Leader, especially in the summer, is that the Trip Leader *does not eat dust*! There! The secret is out!

Great info, Wolfie! I have a few things to add:

- 1. I've compiled information on numerous trails that we regularly run. Everything you need to lead these trails can be found on my personal web site at http://www.webejeepin.com/Trails/Trails.htm, including directions to the trail head, GPS coordinates, information about the trail, and printable maps.
- 2. Another option if you are unfamiliar with a particular trail, is to ask someone to "co-lead" it with you. I did this with Jeff Boggs for the Caballo Trip this past Fall. I led the trail and Jeff wrote the trip report.
- 3. Mark mentions that "you are responsible for everyone in the group". Don't let this scare you! Everyone pitches in to help, whatever the situation. You won't even have to ask anyone. People just want to help!
- 4. For the novices . . . make sure your vehicle is properly equipped. I'm not talking about winches and on-board welders. I'm talking about the basics. I have list of "Top Ten Mods" to do to your vehicle on my web site at http://www.webejeepin.com/Glenns_Jeep/top10.htm. On the Snow Run to Abo, we had several vehicles without CB radios. Communication is very important on the trail! I have a very inexpensive Uniden CB in my Jeep; you can get one at Wal-Mart for less than \$50, way cheaper than most other mods you will ever do to your vehicle.
- 5. Also for the novices. Another page on my web site is entitled "For Beginners". I think it contains some pretty good information. Check it out at http://www.webejeepin.com/For Beginners/Beginners-1.htm.
- 6. Regarding Wolfie's comment, "Keep the person behind you in sight ALL the time!" This requires a big "foot stomp". There were times on the Abo run that we got way spread out. No one got lost, cuz the trail didn't have any turns. But with the lack of communication, we were often unaware that someone was stuck at some point. On a trail that has several turns, this is vital to keeping the group together.

Rumbling of Thunder A Whole New Sound in the Off-Road World



Notes from Justin's Photography Class

APERTURE:

The aperture stop of a photographic lens can be adjusted to control the amount of light reaching the film or image sensor. In combination with variation of shutter speed, the aperture size will regulate the film's degree of exposure to light. Typically, a fast shutter speed will require a larger aperture to ensure sufficient light exposure, and a slow shutter speed will require a smaller aperture to avoid excessive exposure.



SHUTTER SPEED:

Shutter speed, or more literally exposure time, is measured in seconds, but often marked in reciprocal seconds. A typical exposure time for photographs taken in sunlight is 1/125th of a second, typically marked as 125 on a shutter speed setting dial. In addition to its effect on exposure, shutter speed changes the way movement appears in the picture. Very short shutter speeds are used to freeze fast-moving subjects, for example at sporting events. Very long shutter speeds are used to intentionally blur a moving subject for artistic effect.

ISO:

Film speed is the measure of a photographic film's sensitivity to light, determined by sensitometry and measured on various numerical scales, the most recent being the ISO system. Relatively insensitive film, with a correspondingly lower speed index requires more exposure to light to produce the same image density as a more sensitive film, and is thus commonly termed a *slow film*. Highly sensitive films are correspondingly termed *fast films*. A closely related ISO system is used to measure the sensitivity of digital imaging systems. In both digital and film photography, the reduction of exposure corresponding to use of higher sensitivities generally leads to reduced image quality (via coarser film grain or higher image noise of other types). Basically, the higher the film speed, the faster the shutter, the worse quality the photo.

"Free" Energy—The Solar Alternative

I lost track of how many different ways I tried to approach this topic. Since many of you are aware of my "pet peeve" about disturbing the peace by using a noisy generator or vehicle engine to recharge camper batteries, I wanted to present it in such a way so as not to come across the wrong way! There really is a much better way to renew energy while "dry camping". Okay, it's not totally free, you have to purchase some equipment up front, and it isn't inexpensive if you get quality stuff. But after that, there's no cost, it's maintenance free, and practically unlimited. I'm referring, of course, to solar power for your camper.

If your style of camping takes you primarily to established RV Parks or Campgrounds (with hook-ups), then you probably won't be interested in this information. But if you do a lot of "dry camping", there are numerous benefits to installing a solar system in your rig. I hear a lot of people say that the initial cost of a solar system would take too long to "pay for itself". The alternative costs more than you may realize; not just in money, but also in time and personal comfort. For example, generators require fuel, which cost money. When you run out of fuel, you have to go get more, which costs time (and fuel to drive to get more generator fuel). Generators require maintenance, more cost. Draining your battery to the point that you camper's CO detector starts to beep, *dramatically* reduces your battery's cycle life (the number of times you can discharge/recharge it). At \$100+ for a quality RV battery, that's significant. How about the "cost" of a good night's sleep, which you won't get if you have to get up every few hours to fire up your generator because your battery is too weak to run your furnace. I think you get the point.

My RV solar system is about 8 years old now. I originally purchased and installed it on my Class C motor home, and then transferred it to my current Lance camper in late 2003. It consist of two 75-watt solar panels, a charge controller, a combination volt/amp meter, and two 105 Amp Hour (Ah) RV/Marine batteries. Except for the batteries, I purchased everything from RV Solar Electric (www.rvsolarelectric.com) out of Scottsdale, AZ. Installation is a relatively simple "do it yourself" project. This system will operate everything in our camper, except for the air conditioner and microwave. I've dry camped for as long as a full week at a time, and have never run out of power! My system has *long* since paid for itself. With the constant gentle charge from the solar panels, my original two batteries lasted nearly six years! The ONLY maintenance required is to periodically check the water level in the batteries.

As a recent example – Gordy's Hill for New Year's weekend. Temps at night were in the low to mid 20s. Jan doesn't like to be cold, so the furnace gets set between 68 – 70 degrees in the camper – all night! We woke up the next morning after a really good night's sleep and learned (from our volt/amp meter) that we had used only 25 Amp Hours of power through the night. That's about ¼ of our usable battery power. With two 105 Ah batteries (for a total of 210 Ah), I can safely use 105 Ah before having to recharge (you don't ever want to discharge more than 50%). By the time we returned from the trail ride that afternoon, both batteries were back at 100% and ready for another cold night.

If you are interested in learning more about solar systems for your camper, I highly recommend the "RVers' Guide to Solar Battery Charging", by Noel and Barbara Kirkby, owners of RV Solar Electric (www.rvsolarelectric.com), \$15 includes priority mail shipping.

Hello everyone--Just a quick update as I am getting ready to head down to the Chile Challenge.

The first (Jicarilla District) of the three Carson National Forest EA's covering their five Ranger Districts is out for public comment. The deadline for comment is March 12th. You might remember these EA's from late last summer. The Carson decided to re-issue full EA's after we wrote letters complaining about the lack of information in the first round of EA's released. The 2nd EA (El Rito/Canjillon/Tres Piedras) is expected in mid-March with the Questa District following sometime soon after.

We still expect the Santa Fe National Forest EIS to be released sometime in late April.

Secretary's Report- Jeanne Meier: A motion was made to accept the minutes as published in the March newsletter, motion carried.

Treasurer's Report – Mike Coe: Mike reported a balance of \$3,174.62, which included some checks for the Summer Quarterly.

Report – Cliff Meier: For the Riley Run, Too Tall Tony (Louderbough) was fined for being too short and having to be strapped off an obstacle. The Farmington BLM released a proposed action for the Chokecherry Canyon/Glade area. Currently, this is approximately 18,000 acres adjacent to the city of Farmington with 3,000 acres open; the rest is limited to designated routes, although this hasn't been properly implemented. The action would make 8,000 acres of the designated area either single track trail, motorized with an alternative to be single track, or not motorized.

Riley Run

Saturday, March 6th, 2010, the New Mexico 4 Wheelers did a club trail run to Riley, New Mexico. Riley is an old farming and mining ghost town southwest of Belen, NM. Or, you can get there from Magdalena, by driving twenty miles north to Riley. Russ Kaz and I were trail leaders, and we chose to leave Belen after everybody had gassed up at the Wal-Mart

About 15 4x4's met us there. We had a short driver's meeting, handed out maps, and left about 8:00 am, going south on I-25 for about 20 miles to the Bernardo exit. The group went down the road past the Kiva RV Park and Horse Motel, Old Hwy

60, across the old bridge over the Rio Puerco, and stopped to air down. One more vehicle joined up with us there.

The next 20 miles was "high speed" dirt road with plenty of dust to go around for everybody, except the trail leader, Paula and me. This may be the best reason for someone to volunteer to lead a club run. I have found that most everyone (on the club runs that I have led) are able to adapt to the situation they are in, so everybody just spread out.

We gathered back up a few miles east of Riley and came to the "Fork in the Road". Yes, a real fork on a post, with direction signs. We went right, past several occupied houses, ranches, and after several miles turned off this main west-bound dirt road, onto a small two track to the south. The key to finding



this turn off is looking for some big boulders on the side of a mesa. Driving toward them, we soon entered an arroyo that doubles as CR12, County Road 12!! Like Wolfie said, "This is not your ordinary County Road, even for New Mexico".



We took a break, disconnected sway bars (most of us) next to a windmill. We moved off through a gate and entered Forest Land. This is part of the Cibola National Forest, Magdalena District, and the foothills of the Bear Mountains.

This becomes 4-low range territory. Although not difficult, there are places to play, and that is exactly what some of us did on some sandstone ledges on the side of the arroyo/county road. Pat Brady saw a rocky section a mile away, and soon had talked several of us "small-wheeled" jeeps into trying a

pretty steep drop-off. With Pat's expert spotting, everybody made it down with just metal/rock noises. Chuck Peoples even went back UP the ledge, successfully. Off the group went, up the arroyo, a few miles, and turned south, up and out of the arroyo, onto the next part of this county road (some maps designate this FR 12).

This area goes up and down, with lots of twisting and turning. The road is little used, but easy to follow. It would be real interesting at night, any takers? Alamo Well, Cement Trough Springs, and Fall Springs are some of the landmarks along this road, inviting great places to tent camp and hike up and down the arroyos in this area. But the highlight of the trip today was to get to the "Pot Hole" for lunch. Going east down an arroyo took us to this area for a 1:00 lunch break. There is a road that takes the vehicles along the side of the Pot Hole and down to the bottom. This part is washed out and tips 4x4's driver's-side down hill, but everyone made it to the bottom safely. Lunch time and time to look at



the Pot Hole, searching for a path up this long sandstone waterfall. This solid rock waterfall has ledges, off cambers, tight squeezes for small tire 4x4's, and some extreme lines also. Several people tried the north side of the obstacle. A good spotter helped guide the vehicles, but there were always sounds of high centering, and nearly everybody had to back up and change their angle of attack, especially near the top where a tricky, extreme tilt to the right had all the vehicles getting very close to a large rock outcropping that could cause right rear body damage. Pat and Sue Brady (and "Taylor" the Wonder Dog) drove their Tacoma up and out, becoming the first ever truck to do this area. Seeing this made up Cliff Meier's mind that he had to try his luck going up the Pot Hole. Up into the entrance, over the first ledge, and a high center or two got Cliff to the dangerous tilt-to-the-right section. He got his jeep up in the air, left front tire, then rolled back out of it slightly, and tried again and again before he felt that left front tire finally start to lower back down to earth. After that, Cliff's jeep worked its way across the top and out onto flat sand.



Anybody else still down at the bottom drove back up the bypass road, which was not that easy, with its wash out, off camber section. Cliff did mention that he had never disconnected his front sway bar, and this contributed to his lack of flex, but definitely increased the entertainment value of this lunch break.

Back to CR 12B, we worked our way back to a couple of gates on FR 354W. There are several other short side roads off this main route, but time to get to Riley. We got back on FR 354, turned north, and then turned to the east and across the Rio Salada.

Riley is on the other side of this flowing river. Riley was a farming and mining area. Gold, silver, lead, and coal were sent to Denver for treatment. There is an old school house, and a little church that has a mass one day a year. Other adobe walls are scattered about.

The group checked out the buildings and visited for a while. Time to get back to civilization, so we headed back toward Belen on the same dirt road that we had been on this morning. Great views of Ladron Peak (to the south) were visible through the dust clouds that we generated on the way back down into the Rio Grande valley.

We hope to do this trip again, and for those who missed out, try to make it next time. Special thanks to Russ and Glenna for tailgunner duties, like gate closings and general herding of the group. We also did a pre-run of this route and pictures are on the Picasa club site of both runs. Please send in your



pictures, also. It was a great group to show around and this made our day pretty easy.

Looking forward to the club trip down to this area on Memorial Day weekend. See ya there!!!

I've talked to Moms worried about their kids having a place to ride as they grow up. I've been around many a campfire where sons talk about the places they used to go with their Dad, and no longer can go due to some unnecessary Wilderness or trail closure. I've seen the tears of old timers who have witnessed their heritage being stolen, one gate at a time. It stinks!

The message is clear. We need action and not just words. We need folks to take up pens, shovels, and dig out the smelly stuff to root out the problems. We need unity in our action and harmony in our voices. But most importantly we need to <u>do</u> something. OHV enthusiasts, four-wheelers, snowmobilers, and riders from all over agree: it is time to unify more and fight back to stop the stink.

Join up or renew your commitment to BlueRibbon Coalition, your state association and those groups that make sense to you. Do it today. Write those letters and sign those petitions when asked. Do it when asked. And if you really want to save our recreational future, go get 10 of your non-joining friends and fellow motorheads to do the same. You can make a difference, and you can help stop the stink.

Discoverers, Developers, and Merchants How "old west" gold mining and modern landuse are similar

The old prospector no longer gave a hoot about all the talk of getting rich during the 1849 gold rush. No matter how he looked at it, it was dang hot and ugly mean in the western desert, and he'd not had a decent drink of water or a good meal in days. He was hot and tired; his mule was dragging; and his supplies were about gone. He was having about as much fun as a jack rabbit at a coyote picnic.

With no gold in his pockets, he gave up for the day and settled in next to a ledge of rocks that provided some shade. He tipped back his sweaty worn-out hat and began to collect a few rocks to make a small fire ring. The last of his hard-tack would taste mighty fine about now and he still had one can of beans to heat up. Then it struck him like a mule kick in the butt! His fire ring of rocks was the best gold ore he'd ever seen. He was suddenly going to be a rich man living the life of luxury.

The old prospector was a "discoverer." Discoverers are those that find the ore or the strike, but usually don't have the capital to develop a gold (or silver) mine. Sometimes in the 1800's it was common to have to sink a shaft 200 - 300 feet or more to get the "good stuff." So the discoverer would sell out to the developer, who did have the money, manpower, and backing to fully develop the mine.

Of course, all this while the merchants -- the business men who brought the shovels, beans, bullets, and other supplies that miners needed – were establishing the long-term trade and supply routes to build this country while supporting the mining development. It all came together, the discoverers, the developers and the merchants. Today, landuse is not much different.

In short, the discoverers in landuse are the local folks who are "prospecting" their way through the maze of government, just trying to recreate and enjoy the great outdoors with their toys. Discoverers find problems (bad government decisions, unnecessary road closures, unwarranted gates, etc.), then bring in the developers (larger landuse organizations) to help out. Merchants are the off-road businesses of today who support the developers. It all comes together – just like in the mining days of the "old west."

Allow me to break this down for you a bit more. Let's take the example of a "local Joe," just a lone-ranger kind of recreationist, who finds that his favorite trail is being closed up tighter than a tick on a hound dog. He makes a few phone calls; writes a couple letters; and gets the typical run-around. So then he moves it up a notch and finds a local club to engage in the fight. "Local Joe" is our prospector who gets things started with his local knowledge, expertise, and passion – he's the discoverer.

Soon it becomes evident that professional help and perhaps even legal advice might be crucial in saving this trail, so the locals reach up to the bigger organizations at the state, regional, and national levels – the developers with the money (hopefully everyone has been joining and supporting these bigger organizations so they do have some strength). Naturally, the merchants – the off-road businesses – are in the game as well by supporting the big orgs and clubs out there prospecting and developing to help keep the gold mine (the sport) alive and well.

It all comes together, just like in the old mining days of the American west. Well, that is to say, if we're all working together, making the system work, and finding unity in our voices.

If you read my writing very often, you know I love metaphors and analogies. This piece is no different. Here you go. Our freedom to explore is a treasure in this great country of ours. Our recreation is a gold

mine, if you will. Be a "discoverer" who works to prospect for new ways to keep our sports alive and our trails open. Join and support the "developers" who are the big orgs helping to support you and your local trails. Finally, buy from "merchants" who support our local, state and national efforts, as we all prospect for a brighter, gold-filled future. \odot

Memorial Day Campout

Back in January, Wolfie and I traveled down to Socorro to attend one of the Magdalena Ranger District's Travel Management public workshops. Pat and Sue Brady were also at this meeting. After the Forest Service did their presentations, they had the attendees mark comments on maps they had printed of the area which contained all of the roads that the forest service presently have logged in their inventory. Pat has spent a lot of time in the district and I listened as he described things while marking up the maps. I had always wanted to explore within the Magdalena Ranger District, ant this pushed me to make some plans for the Memorial Day

weekend.

We decided to make it a longer holiday weekend and arrived at our campsite on Thursday afternoon. Our first choice was the Montosa RV park, but it had changed ownership and closed, so we found a nice spot on a strip of BLM land ~12 miles West of Magdalena just off of US 60. The next morning, a small group set off for the mountains near Datil, NM. First stop was Davenport Lookout where we had a 360-degree view of landmarks such as Mt. Taylor, the Zuni Mountains, and the San Mateo Mountains. There was a forest service employee in the lookout tower (on the watch for forest fires) who appeared to enjoy having some visitors. From here,



the plan was to head north and make a loop back to highway 60 out to the west. Part of that loop exited the forest land at the northern end for a short distance where we ran into a locked gate. We were then forced to backtrack the way that we came in. Once we hit the highway and aired up, Cliff suggested that we go to Pie Town since it was just over the Continental Divide from where we hit the highway. We all enjoyed having a slice of pie at the Pie-o-neer in Pie Town.



Saturday, Pat Brady took the lead and took us on a tour of the San Mateo Mountains. With a total of 16 vehicles, we headed south from camp, passing by Monica Cabin FR 52 and circling around the east end of the Mt. Withington Wilderness area. That evening, we all gathered for a pot luck dinner and a campfire afterwards. We expected that it would rain, based on experience from last year's Memorial Day campout in the Jemez and being a firm believer of Murphy's Law. The weather was perfect! The food was excellent as was the company. The Duggars really outdid themselves by bringing a delicious pan of brisket that they had brought back from Texas. The turnout for this was great! We also had a few folks from the High Desert Cruisers 4x4 club join us and they are a fun group. After the pot luck, we had a campfire and made smores.



From the Office of the Director of Environmental Affairs

Hello everyone,

The Santa Fe National Forest has released the Draft Environmental Impact Statement (DEIS) for public comment! This is the big one. This is what we have all been working so hard for AND where we get to put our training to use.

A couple of KEY points:

1. There is a 45 day comment period. But the clock hasn't started 'ticking' just yet. The 45-day clock will start when the Legal Notice is published in the Federal Register. I will keep on eye on that and will let you know the deadline when we know it. In the meantime, the DEIS document is out and available for review (and comment) on the SFNF website. The link directly to the document and maps is:

http://www.fs.fed.us/r3/sfe/travelmgt/deis/index.html

2. Only those people who submit <u>substantive comments</u> by the comment deadline will be able to appeal the Final Decision when it is released

A substantive comment is one that:

- (a) questions, with reasonable basis, the accuracy of information in the EIS;
- (b) questions, with reasonable basis, the adequacy of environmental analysis;
- (c) presents reasonable alternatives other than those presented in the EIS; [or]
- (d) causes changes or revisions in the proposal.

The only things the public can do to oppose a decision from an EIS are 'comment on the draft EIS, appeal the final decision, sue if the appeal is rejected'. And they are all linked. It all depends on the comment you write on the Draft EIS. Your appeal has to be based on the comment you submitted during the comment period on the Draft EIS. You can't file a lawsuit unless you have gone through the appeal process. Your lawsuit is based on the comment you appealed.

What does a lawsuit say??? A lawsuit says a law has been broken!!!! The only law that controls the travel management decisions are the NEPA regulations. The only things the NEPA regulations specify are requirements for the <u>process and procedures</u> the agency must follow when it is doing the EIS and making the decisions.

Therefore, the only way you can accuse the USFS of having broken a law, is to show they didn't follow NEPA process and procedures as required by the CEQ regulations (Those are part of federal law, the Code of Federal Regulations, the 'CFR'). This why we must write comments that show the USFS did not comply with the required process and procedures.

But remember, NEPA requires that the Forest Service use the best available science and that they draw logical conclusions based on facts. If they play 'fast and loose' with the facts and use those errors to make a decision, you can point out the error that caused the bad decision. That is a substantive comment!

3. I have only done a cursory review of the DEIS so far, but it looks like most of the requested trail segments that NM4W asked for are at least included in Alternative 4 (including the entire Hill and Dale trail, the Guadalupe Crossing up to Holiday Mesa, etc). This is very good. The Deciding Officer (in this case, the Forest Supervisor, cannot choose to include things in the Final Decision that are not in the Alternatives. He <u>IS</u> allowed to combine elements from various alternatives into a single decision. THIS IS IMPORTANT: Again, remember sending in a comment that says, "I support Alternative 4." Or "Alternative 4 is better than Alternative 2 is better because it has more roads open," is NOT a substantive comment.

NEPA controls the PROCESS used to make the decision, but not the decision itself. If we don't agree with the decision, we need to provide facts that show the decision was flawed because the underlying errors in the document caused the decision maker to make a bad decision based on those errors.

- 4. I expect NMOHVA to sponsor another training session on how to write a substantive comment on the DEIS. If you weren't able to attend the last training and want to attend one, please let me know ASAP so I can get your name on the list. I will advertise the date and information of the training session if/when the details get worked out.
- 5. All the effort the club and you, as individuals, have put into Travel Management on the Santa Fe National Forest has come down to this 45-day period. This is not a drill, this is the real thing. The efforts we put forward during this comment period will DIRECTLY affect our access to the Forest for the foreseeable future.

I will continue to feed more information to all of you as I get the opportunity to review and analyze the document. In the meantime, please feel free to email or call me with any questions, suggestions, information needs, etc.

Manzano Mountain Trail Run – July 11, 2010

This run was into an area that Bob Telepak had mapped a couple of years ago in preparation for the Manzano Ranger District Travel Management plan. That fall we assisted in finding some roads that were on the National Geographic software map that Bob had not traveled. In November 2007, the first of 4 fires hit the Manzano Mountains and the area was closed until this summer.

The day dawned with some cloud cover, but 12 club member and 3 visitor 4X4s with accompanying hardy souls met at the Sandia Ranger station and proceeded 45 miles to the trailhead for a day in the

southern Manzanos. As we passed through the village of Manzano, we picked up another Jeep. The first half of the trip on FR 522 wound through an old CCC camp, a logging area, past the ruins of an old stone house, and through the edge of the 2008 Trigo forest fire area. During the pre-run we saw a small bear in this area, but he didn't hang around to greet the group! After exiting FR 522, we proceeded to Dr Bob's Rocky Road off FR 422. The rocky road provided slight challenge to stock vehicles, but a visitor driving a new Nissan Xterra managed to remove a side step on one of the rocks. We stopped at 5 Mile Windmill for lunch before continuing SW and then looping back to the north in search of Hidden Canyon. Hidden Canyon was a road on the National Geographic software map, but had been lost to time. It is not expected to be on the Ranger District's formal motor vehicle usage map. However, it is the fastest way out from the south end of the Manzanos. There had been a flash flood through the canyon earlier this year that had washed out sections of the road and made it slightly more challenging.

As we made it back to the main road and aired up, the rain started. Part of the group braved the rain and stopped at the Quarai Ruins just west of the village of Punta de Agua. With the exception of the fire areas that have been logged, there was very little evidence of any other vehicles. Overall it was a good run with the cloud cover keeping the temperature down and no vehicle problems except for the Nissan's side step. As a side note, the visitors must have liked the run because they have all submitted membership applications!

We could not have been successful without your participation.

As you all know, Mark Werkmeister' term as the club's Director of Environmental Affairs has been completed. Mark has done an outstanding job. It takes a special person to do this important job. Mark Wolf (Wolfie) has taken the reins from Mark at a critical time. Within the last few weeks, three important documents that will determine which 4X4 trails will be open for us to use have been published. The documents are the Mt. Taylor Travel Management Environmental Assessment, the Santa Fe Draft Environmental Impact Statement (DEIS), and the Magdalena Travel Management Proposal. The Santa Fe DEIS includes the Jemez Ranger District, which is an area that we wheel in. It is very important that as many of us as possible get involved in the comment process for these documents. During the Creede Quarterly, we had a visit from the local COHVCO representative, a Colorado off road organization similar to our NMOHVA. The discussion turned to the Rio Grande Forest Service Ranger District's Motorized Off-Road Usage Vehicle Map. This Ranger District's map was published in 2009 when their travel management process was completed. There were two very distinct examples of what happens when there is little input from the user community. The published map has only 17 miles of ATV trails. Secondly, this Ranger District contains the headwaters of the Rio Grande River. These headwaters are a trophy trout fishing area. The published map does not include any of the existing river access roads. So, my point is please get as involved as possible!

I'm excited with some of the new wheeling opportunities, along with our traditional runs in the coming year. Wolfie and Tony Louderbough (our Trip Chairman) are working to set up joint runs with other New Mexico 4X4 clubs. The first is a weekend trip with the Ruidoso Ridge Runners at Bonita Lake outside of Ruidoso. In addition, Pat Brady is organizing a trekking type trip in the Gila area. If there is a run you would like, contact Tony and let him know. Don't be surprised if he tries to recruit you to lead it! We need more folks to lead runs. It's not that hard and there is lots of help to get you started.

One last thing, I have noticed that attendance at our monthly meetings has dropped off, both last winter and this summer. It is important that as many folks as possible attend the meetings. This is everyone's club, but if you don't come to the meetings you won't be able to influence the direction the club goes. Next month I plan to send out an e-mail questionnaire on how we can improve meeting attendance and the club overall. Please respond. All responses will confidential.

Thanks again for letting me be your president for the next year and let's get out there and have fun wheeling!!

From the Office of the Director of Environmental Affairs

Hello my friends and club members,

This is my last update for a while as Mr. Wolf has graciously stepped forward to take the role as DEA. I appreciate him doing so and hope that you do to!

Never before in the history of our club have we had so many important processes going on with the land management agencies. The outcome of these changes will affect our four wheeling opportunities for years to come, maybe forever. On the other hand, never before have we had better tools and capabilities in our hands to truly make a difference. And never before have we been so involved in ensuring that we have places to drive in the future. Here is the current list of projects and their status:

Cibola National Forest -

- Mountainair Ranger District The Draft EA has been issued, we provided our comments, and we are waiting for the Decision Notice and Appeal period.
- Mt. Taylor Ranger District The Draft EA has finally been issued. Substantive comments on the Draft EA are due September 14th.
- Magdalena Ranger District The Proposed Action has been released. This starts the NEPA process with the official Scoping Period. By the time you read this, the Scoping Period will be closed (August 24th). The Forest Service will then move into their analysis phase and release the Draft EA with the Alternatives sometime later this year.

Carson National Forest -

- Jicarilla Ranger District The Decision Notice has been released (published on August 19th) and the 45 day Appeal Period has started. All appeals must be submitted by October 4th.
- West Side Districts (Tres Piedras, El Rito, Canjilon) The Draft EA was released and the comment period has closed. We are waiting for a Decision Notice.
- Questa District The Draft EA has not yet been released.

Santa Fe National Forest –

• The BIG one for the club. The Draft EIS has been released and substantive comments on its contents are due by September 30th.

The Gila National Forest –

• We are still waiting for the Draft EIS to be released.

Taos BLM -

• The draft EIS for their Resource Management Plan revision has been released and substantive comments are due by September 9th.

Wow! It kind of makes your head spin, doesn't it? Unfortunately, there are a lot of things in the above documents that would stop our wheels turning forever. You can make a difference, let's get after it.

Jemez Run By Jeff Boggs



The NM4Wheelers had a club trail run on Saturday, August 21st. We started gathering up at the gas station at the corner of Hwy 550 and Hwy 528 at 8:00 AM. The sun was up and one by one, 4x4's started driving into the parking area. By 8:30 we had 31 vehicles. WOW! Members just barely out numbered guests.

We had sign up, drivers meeting, and away the caravan went, at a nice slow pace, all the way to the Walatowa gas station on Hwy 4, in the Jemez Mountains. Air down, gas up, disconnect, and a quick meeting of the minds determined that with such a long "train", we should divide up the

group into two. I led the first group, with Rance as tailgunner, and Jared leading the second group and Wolfie was the final tail gunner.

We were able to keep the group close most of the day, thanks to CB talk. The trip was up Paliza Canyon that begins at the Paliza Campground, north of Ponderosa, NM. This is a narrow road with rocks, and trees close to windows, so drivers had to pay attention. We had one breakdown in Paliza. Tommy had a beautifully restored International Scout that he brought on the run, but the fuel pump gave out. Unable to continue, his Dad had to strap up the silent Scout and with his Jeep, they turned around and headed back to town. Hope they made it OK. Tommy, if you read this, let us know how it went.





We stopped in an open meadow in the canyon for lunch, at 12:00 noon. It was really green in the entire canyon. After lunch, several people took a short cut back to town, because of work considerations later that day. We are now 26 strong and headed up the trail. Through a gate and hang a left, we then headed onto a very narrow road. This old forest road has no number designation that I can find, but a guy on an ATV once told me it is called Water Canyon. On the pre-run trip through here two weeks ago, I brought my chain saw and needed it to clear a big fur tree off this road. I did not bring it on the club run because, what could happen in the forest in just two weeks time. I have been too

optimistic before and I will be again. Anyway, I came up to forty foot of aspen tree, in a near horizontal position, right across the road, with no way around. The caravan came to a stop and out came the opinions, but no chain saws. After a few moments the best idea seemed to have me drive over the lowest part of the tree (Is a tree still a tree if it has fallen down, or is it a log?). To the right was a steep drop off and to the left too much "air log". Pushing another helper log in place, over I went to the other side. Mark Woolfson said I barely kept my front passenger tire from going over the side. I wheeled around and out came the winch and strap, and in about 15 minutes the road was open again. The only damage was a rat's nest of cable in my winch. I will pull that out tomorrow and try to wind it up all pretty again. Am I being too optimistic again?

Onward through to the summit, quickly named "Black Cow Pass", and down into the greenest part of the Jemez Mountains that I have ever seen. Ferns, moss, and mushrooms surrounding nice flowing spring were all around us. During a 10-100 stop, I asked Kim how she was doing in her stock TJ that she had bought only two weeks ago. She said that she had four wheeled quite a few years ago, but she was scared several times today, hearing a scraping sound here and there. The smaller the tires, the bigger the rocks! But several people who had seen her in action all day long were very impressed with her driving ability. She said all the positive encouragement from everybody really made her feel good. We finished Water Canyon, but it was already after 3:00, so we skipped going up to the Cerro Palado Lookout Tower and headed back to FR 10. Going south from there takes us back to Paliza Campground, where we had

started that morning. From there, some went back to Walatowa to air up and chat about the day, others headed on home.

All in all, the day went real well, considering the large number of vehicles that were on a tight, rocky, slow trail. As always, the main reason things went well is that the members of the New Mexico 4-Wheelers worked together to have a great day out 4-wheeling and enjoying our National Forests. And we had a great group of guests that "went with the flow". We hope all these Forest Roads stay open for motorized recreation. The comment period for you to write the Santa Fe National Forest is only a few more weeks. Please visit the NMOHVA web site at www.nmohva.org to find out more information on how you can make a difference. On some of the



Alternatives that the Forest Service is considering, Paliza Canyon would be closed to any motorized travel. We did absolutely no damage with 30 plus 4x4s, by staying on the trails, picking up litter, and practicing common sense driving techniques. And besides only seeing two ATVs, we were the only ones in that area all day, on a Saturday, in the summer!! This area is not overused. Gila Trekking Trip – September 22 - 26, 2010 By Pat Brady

Hi Everyone,

I thought I would take a few minutes to let all those that are going on the Gila backcountry trip what's going on and the approximate trip itinerary. Right now the trip plan is to leave on September 22nd from the Belen Wal-Mart at 9:00 AM. The trip will finish up on September 26th somewhere in the Blue Range Primitive Area or the Apache – Sitgreaves National Forest. This trip will be slow and easygoing ... if you are a type "A" personality, this trip is not for you.

Wednesday: From Belen we will head to Magdalena to top off the gas tanks. We'll head west on Hwy 60 and turn off south on 168 heading towards Mount Withington. Somewhere between Mount Whitington and Grassy Lookout, we'll find camp for the first night. I know that this seems like a short first day, but I want to set the "tone" for the rest of the trip, break camp at 9ish and make camp at 4ish. Sights see, take pictures --- RELAX dang-it.

Thursday: The next day will be a bit longer. After we break camp we'll head down Hudson Canyon out to State Rd. 52, then to State Rd. 163 heading for Beaverhead where we'll find little canyon. I have not driven completely through yet, but this canyon has near vertical walls of basalt with some areas never seeing the sunlight. After that we'll head west on FS 141 / State Rd. 59 to FS 142. Somewhere along, we'll find camp or we might stay in the area of Snow Lake. This lake is right on the northern edge of the Gila wilderness. This is one of the most remote, drive-able places in the Gila. There are fish stocked here, if you need to drown a worm or two. You will not see any city lights --- not even the glow. I hope the skies are clear that night as you will see so many stars.

Friday: This will be a mixture day – dirt roads – Alma – gas – pavement – dirt roads. We'll continue along FS 28 / State Rd. 159 to Alma. Get some gas, head north along State Rd. 180, turn off on to FS 232 and head towards the Blue River. Most of the route will be along the northern edge of the Blue Range Wilderness. It has been a long time since I was down along the Blue. What this means is we will need to be flexible when it comes to finding a camp site. We will be in the heart of the Blue Range Primitive Area. This is a very remote area. Again you will not see the glow of the city lights. Also note this is part of the Lobo reintroduction area. You should plan on keeping a clean camp.

Saturday: This will be a mixture day also with us backtracking along FS 281 heading for Alpine, Arizona. We can gas up for the drive home on Sunday at Alpine. Out of Alpine we'll head for one of my favorite camping spots, it is a small ridge about 8500' just east of Escudilla Peak. I have taken great photos looking west as the sun sets and east at the sunrise. There are some great views of the Apache – Sitgreaves National Forest to the west and east. The elk will still be in the rut ... so maybe we'll call some lovesick bull into camp that night.

Sunday: Break camp about 9ish to head out through Spur Lake basin and Bill Knight gap north to US 60. From here it will be paved road all the way back. I normally take NM 36 / 117 from Quemado; this will take us across the North Plains back to I-40 and Albuquerque. The trip from camp is about 5 hours. This will leave lots of time to unpack and reflect on the trip.

Bottom line: This trip is highly flexible for you. If you see a road you want to take—we can, we'll just adjust the time for camp to make up for it. If the trip is too slow for you and you just can't stand it anymore, there are lots of roads that you can take to get back to the "rat race" anywhere along the way. There are not any iconic views of big holes in the ground, no towering mountains, no raging rivers, just wide open spaces with lots of trees and great camping and no city lights. The last things you need to know are you must be self-sufficient. There is not any gas from Magdalene to Alma. There is limited to NO cell service for the entire trip. Water --- bring your own. We may be able to get some at Alma ... I don't know, I have never tried. Please send me an email message confirming your wish to go. When I return from my elk hunt, I will contact everyone. If you have any more questions, email me at pbrady4x4@hotmail.com. Thanks.

The Jeep That Saved the Day (and our lives)

The trucker behind us on I-80 near Truckee, CA, said he figured we were goners when the Jeep made the FIRST "360" at 55 MPH on the freeway with the jeep trailer coming disconnected (yet upright), held only by the safety chain. Then when he saw me steer out of that for the SECOND spin with the trailer headed sideways and still flopping on the chain, he knew we were going to be statistics. Yet we survived it; no one got hurt, and after a few repairs, we drove home the Jeep with the trailer. It's a story worth telling.

"Red" the Jeep stayed upright and we must have had the luck of the Big Four-Wheeler in the sky watching out for my driving. I'm still celebrating life even more today. But this story is also about the right gear; the right buildup on your rig; the right training; and the family we call four-wheelers, or better yet, off-road recreationists.

Stacie and I were returning from Sierra Trek by CA4WDC in freeway traffic on I-80 when we think the trailer ball bolt sheared off and let the trailer fly loose from our Jeep at freeway speed with a semi-truck behind us. Thankfully, the trucker was not tail-gating!

Stacie happened to notice the ball bouncing harmlessly off the freeway into the dirt lane right before I felt the trailer coming around to visit me in my driver's window. All hell broke loose after that.

The stink of rubber burning whiffed by my nose as the sound of metal crunching and banging together filled my ears. We could faintly hear brakes behind and alongside us locking up, but instantly the world started to rotate the wrong way and the only thing I could say was "hang on."

Stacie grabbed the passenger bar and leaned towards the middle as my hands bore down hard on the steering wheel, anticipating the drift and slip of the front tires as the Jeep got tossed by the weight of the speeding trailer. I've been through skid pan and safety clinic type off-road training, so I knew to stay

with it; turn into the skid; and use the brakes carefully so as to not slam the trailer into the Jeep too hard thus canceling my steering efforts.

Turning the Jeep in a drift towards the far right lane and dirt ditches alongside the freeway was my mission. Red was as stable as I could ever imagine, and I could feel the steering respond the way it should. But the weight of the flinging trailer and our freeway speed put us into the first "360" spin on pavement. Then we skidded into the dirt and began our second spin as gravel and dirt flung up from the BFGs, filling the cab with a dust ball that nearly stifled our breathing. Losing visibility, I had to rely on feel and instinct to make the last couple turns, fighting the skid and still turning into the drift trying to keep Red upright, rubber side down. It worked!

Thank goodness the Jeep is built right! The MFS custom steering and PSC hydraulic assist is one-ton stuff with CTM U-joints and BFG KM2's clinging to the pavement. The Jeep's suspension is Rubicon Express long arm heavy duty stuff with RE shocks as well. Hanson bumpers provided a lot of rear end strength, in spite of the trailer dragging by the safety chain. And I'm convinced the Raceline Monster Beadlocks kept us from popping a tire off the bead during the pavement burning spin.

The Altop family of wheelers (Gerald Sr. and Jr. and Ron) was coming down the highway, returning from Trek and immediately pulled over to help get the trailer upright. They just happened to have a spare tow bar and proceeded to strip off my hitch bent parts and replaced them with their stuff. They even had a spare ball hitch but it was too small, so we broke out the Premier Power Welder and they put a blob of weld inside the hitch to make it fit and viola, we were on our way within about 45 minutes.

The Altop's (who are members of the Sacramento Jeepers of the California Association f 4Wheel Drive Clubs) even took the time to pull over with us at the next freeway exit to check if everything was working okay with the "trail fix" that they did. I gotta say that the off-road community is really a great network of people that go over and beyond the call of duty to help a friend or acquaintance in need. Thanks again to all that stopped to help and make sure that we were okay.

Here are the lessons that were ingrained in my brain from this event. I don't pass these along lightly.

Maintenance and Checking Your Gear: Although I had tightened everything with a pipe wrench after coming off the dirt, that didn't prevent an old worn bolt from shearing off. I recommend you always double check gear and anything that can kill you like trailers, brakes, tires, steering parts. And did you know that trailer balls have torque specifications. Check this out: http://www.hitchinfo.com/index.cfm?event=f ag&topic=223&question=1752



Training and Driving Skills: I've taken my fair share of driving training, including skid pan driving, as well as off-road safety clinics. I can recommend that you consider something like Badlands Off-Road Adventures and 4WD training (http://www.4x4training.com/), and the safety clinics put on by state associations like the California Association of 4Wheel Drive Clubs (http://www.cal4wheel.com).

Off-Road Family: Never take it for granted how special off-roaders are to each other. We are a family and I've seen it over and over. This episode was a clear reminder of a lot of things, and makes a person think about things like luck, life, and yea, divine assistance, as there were a lot of variables in this incident that could have changed a lot of lives. The tow ball bounced down the freeway, harmlessly landing off to the side rather than becoming a hand-grenade through someone's windshield; the trailer could have busted out into traffic; the jeep could have flipped, rolled and bounced several times; and the trucker could have slammed into us sideways after we quit spinning; etc.

But none of that happened. Whew... so cheers everyone! Here's to another day of being a part of the off-road family.

Mt. Taylor Fall Colors Run

Fall is my favorite time of year. With the onset of fall, I always look forward to the cooler temperatures, hot air balloons, and the autumn foliage. Labor Day weekend the Whistons did some exploring on Mt. Taylor with a few other club members and liked it so much, we made plans to return with hopes to see the Aspen trees change color. On Saturday October 9, 2010 a group met early in the morning to climb one of the tallest mountains in the western part of the state. Leaving Albuquerque, we had 11 vehicles including Ken Tinker, the Provances, the Holfielders, the Bakewells, the Ayscues, the Tanners, the

Patricks along with guests Nick and Sara Frasch and Jesse Michaud. At the trail head, the group met the Brownells and the Todts from Jeeps West out of Gallup NM bringing the total number of vehicles to 13.



The trail begins at an elevation of 6100 ft in Rinconada Canyon and quickly begins to climb the mesa to the east accessing the Cibola NF via FR 400. At one time, this road served as a major access road to the forest based on well graveled sections and a switchback complete with a guardrail. Today, the road has deteriorated such that 4WD is required to traverse the steep climb on the mesa top making it much more fun than the previous description. The road also follows a power line that leads to an electronic site that resides at about 9100 ft of elevation. Wolfie said we were to leave the parking lot at 8:30 am, and after a brief meeting, thirteen 4x4's left the parking lot and headed for the east side of the Rio Grande River. The Caballo Lake State Park is on the west side of the river, and the trail is on the east, with a semi-secret way to get there.

There were several different types of 4x4's on the run: TJ's, Grand Cherokee's, YJ's, JK's, a nicely lifted older Chevy K-5 Blazer, and a Jeepster. As we got closer to the mountain, we turned left and headed up and over a hill and into the first canyon. Once in the canyon, it was time for 4low. We came to the first





ice, either right for the bypass or left for a dry waterfall, with several good sized rocks to negotiate at the top. The Jeepster went up like a champ and, one by one, the Jeeps crawled up and over this 4 foot climb. Tony's Jeep slipped back down the waterfall, and his back tire pushed the nice "helper rock". This made for a bigger gap to the waterfall, but after several more trys, Tony got his TJ, with loaded luggage rack, up on top. A nice Clayton equipped Grand Cherokee, along with Jack and Kathy's Chevy made the climb look easy. Ed's tail gunner TJ rolled right up, also.



The Ruidoso group was lovin' this desert wheeling. They go to the Chile Challenge, so this is a lot like the canyons down there. This dry stream bed is the road for a while, so there were many two foot high boulders all over the trail. Approach and momentum was key. One of the boulders took advantage of a Dana 35, underneath Charlie's Cherokee. Charlie came all the way down from Ruidoso to have his Dana 35 spit out the left rear wheel after trying to get over a tough group of rocks. The caravan came to a stop. No replacement axle was available, so we all began rigging up a way to keep this wheel in place for the towing that needed to happen. With several straps holding a

High Lift jack pressing on the side of the left rear tire, Jared's Rubicon got the "OK" to move forward with the "strapped" up Cherokee in tow. Now this would be a difficult job on a flat dirt road, but we

were in a dry arroyo with several tough obstacles right in front of this arrangement. I was ahead of Jared and Charlie, trying to find the easiest way through the rocky stream bed. Soon, Wolfie hollered for me to back up and strap to Jared's front bumper, as it would take two sets of wheels to get the wounded Cherokee thru this area. To make matters worse, the "jerry rigged" wheel holder was not running very smooth, even with a liberal coating of WD40. Up ahead the road was a steep, loose hill climb. So all three vehicles slowly began the spinning assent to the top, but not without the broken wheel slipping out a few times. This caused us to stop, readjust the straps, and then spin and slowly bounce to the top.



Time for lunch. Not far from this spot there was a good dirt road coming into our route. So Charlie and one of his friends went back to camp to get his truck and trailer. They retrieved his Jeep and made it back to camp. Charlie will repair his ride and we will see him again out on the trail. He really appreciated the help.



The rest of the group was hurried along, up to the radio towers. Great views of the lake and valley! Wolfie knew how much time he would need to make up so the group could get back to camp before sundown, so he pushed us back down the mountain and on to the two track, headed north. This route took us back into a canyon/boulder field road, and we each found a way through. There are several old adobe and rock walls along this part.

We were told that we were now entering the Palomas Gap part of the trip. This road was built around 1900, as a toll road, to provide an "easy" route to get from western New Mexico, to the

eastern part of the state. All kinds of equipment, supplies, and people must have used this road. And what a road it was! Built on the side of a big gap between two mountains, this narrow road is not for the

faint of heart. The passenger gets a great view of the bottom of a sandstone canyon, several hundred feet down, and the driver gets to drive as close to a rock wall as possible. Now Jeeps have just the right axle width to make this happen, but Jack's full size Chevy uses all of the little toll road. So much so, that not long after we got down on the "Flats", Jack had a flat. Seems he was hugging the wall so tight, that he picked up a sidewall puncture. The" Toll Road Gods" were kind, as the narrow toll road would not be where I would want to replace a flat on any vehicle. This fixed, the group got back down to the Rio Grande, and crossed at a shallow place. Back to camp and a pot luck dinner by 7:30pm.



Everybody had a great time on a challenging, scenic trail. We saw nobody else all day. Left nothing, not even tracks on this rocky route. Took only pictures and fun times with us. All agreed that both Clubs should do this trail at least annually. Fall and Spring are the best times, with cooler temps, although it was pretty warm that day. Wolfie did a great job leading the group of 4wheelers through this beautiful desert mountain area. 4x4's are a great way to see this rugged area.

Plan on doing this trip in 2011. I know someone will lead this next year. We sacrificed a Dana 35 to the Toll Road this year, and last year the group gave up rear axle shock mount and flipped a front shackle. Will we ever run the Toll Road for free? Show up and find out.



Recommendation on Brake Parts

(Rich posted the following to a forum asking for recommendations on brake parts. I received an e-mail with a suggestion that I include this in the Trail Tales. -ed.)

Original Post:

I need to buy new front rotors and pads for my 2005 Jeep Wrangler LJ Rubicon. I recently put Goodyear MTR 33"x11.5" tires on it and ever since then the brakes have felt weak and noisy. I had the rotors turned and the pads scuffed and that helped with the noise, but it just doesn't feel like it has good stopping response. The rotors have been turned a couple of times and are out of life. I figure my options range from NAPA OEM parts, to Power Slot rotors with Hawk pads. My questions are:

- 1. Do the higher end rotors and pads deliver better performance?
- 2. Do the higher end rotors and pads last as long as the OEM parts?

3. Is it worth spending the extra money to get the higher performance parts?

Follow-Up E-Mail:

I posted the above message to the group a while back and got some excellent recommendations that I thought would be useful to share with all. I think it would be great if we could all share our results of trying different parts or techniques as I am sure there are many people that are in similar situations and would find them interesting.

There were three solutions that I summarized from the responses I got from the group.

- 1. Install slotted rotors and higher performance brake pads, which should be more tolerant to things such as warping and minor brake fading. I think this is acceptable if running slightly larger tires such as 31"-33".
- 2. Install a larger disk brake setup in the front, such as that from Vanco (http://www.vancopbs.com/product_p/dkj1000.htm) for about \$1K to provide better stopping performance. I think this is good solution if you have the money and are running 33"-35" tires.
- 3. Get a custom brake setup from Harold's Off Again in Farmington. I think this is a complete reengineering of the brake system and is only required if running much bigger tires. I would probably explore this if running 37" or larger tires

Option 1 was the easiest to try since I needed new pads and rotors anyway. I installed the Powerslot cryogenic rotors and Hawk green pads. The overall cost was about \$100 more than installing OEM parts of similar quality. I decided to use cryo rotors due to the fact that that jeep brakes are undersized for the application and the rotors would last longer through overheating situations.

After a few months of use, the results to this point have been mixed. I have seen noticeable improvement in slow speed stops which is about 95% of the braking situations around town. I didn't see much improvement in "emergency" stop situations though. When I have to hammer on the brakes, I definitely can't lock up the tires, I don't have anti-lock brakes, and I still get that helpless feeling like it's going to be a bad day. So, now I have just adjusted my driving habits to ensure I keep plenty of distance between myself and the car in front of me. In the future I may consider adding option 2 if I get tired of this emergency stop problem.

Any other ideas or insight would be greatly appreciated.
